

2010 Dues Schedule

Use the [online calculator](#). Dues are based on your company's gross refrigerated space.* Eighteen percent of your company's dues supports the World Food Logistics Organization (WFLO).

US — Dues schedule below. Minimum dues: US\$1,236.

Canada — 80% of dues schedule. Minimum dues: US\$989.

Europe — 55% of schedule through the first 20 million ft³ (566,336 m³), 10% thereafter. Minimum dues: US\$895.

All other countries — 55% of schedule through the first 20 million ft³ (566,336 m³), 10% thereafter. Minimum dues: US\$680.

* Definition of "Gross Refrigerated Space"

Gross refrigerated space on which dues are based represents the total cubic refrigerated space, including freezers, coolers, and docks, from wall to wall, ceiling to floor, with no deduction for aisles, columns, coils, etc. This includes all space owned or operated by a member or an affiliate of a member. Not included are buildings used in their entirety for storage of product owned by the member or buildings leased in their entirety with no operating personnel supplied by the member company. However, any facility covered by the IARW Insurance Program must be included for dues purposes.

Processing Charge: The non-recurring processing charge of \$175.00 per facility is for the costs of setting up each facility with IARW-WFLO manuals and other important information.

Prorated Dues: First quarter: Full dues must accompany the application. Second quarter: Three-quarters ($\frac{3}{4}$) dues. Third Quarter: One-half ($\frac{1}{2}$) dues. Fourth Quarter: Oct.-Dec. dues waived; dues for the next year must accompany application.
